

The following routes are best if traveling to Asheville by car: I-40 East from Knoxville, TN; I-40 West from Statesville and Raleigh, NC; I-85 to I-26 from Charlotte and South Carolina; and 19/23 South from Johnson City/Bristol, TN. For more complete directions and maps, click here.

For a more scenic and leisurely drive, try the Blue Ridge Parkway. More motorists exit and enter the Parkway in Asheville than at any other point along the road's 470 miles. There are seven Asheville area Parkway exits.

The Asheville Regional Airport is served by two airlines, U.S. Airways and Delta, offering a total of 20-25 flights a day. Local folks also often use Greenville (SC) or Charlotte International for air travel. (Greenville is an hour-and-a-half drive from Asheville; Charlotte is two hours.) There are many ground transportation options once you've arrived at any of these airports. (See below.)
