### **FORMER NAFUSA MEMBER APPOINTED TO FEDERAL BENCH**

**John A. Mendez**, former US Attorney for the Northern District of California (1992-1993) was confirmed by the United States Senate on April 10, 2008 to serve as a judge on the US District Court for the Eastern District of California. His chambers will be in Sacramento. Judge Mendez will fill a judgeship vacant since June 2007, when Chief District Court Judge David F. Levi resigned.

Prior to his confirmation, Judge Mendez served on the Sacramento County Superior Court since 2001. Prior to going on the State Court Bench, Judge Mendez practiced law as an attorney-shareholder in the Sacramento firm of Somach, Simmons & Dunn (1994-2001); as an associate then partner at Downey Brand (1986-1992); and as an Assistant US Attorney (1984-1986). Judge Mendez received his B.A. from Stanford University and his J.D. from Harvard Law School.

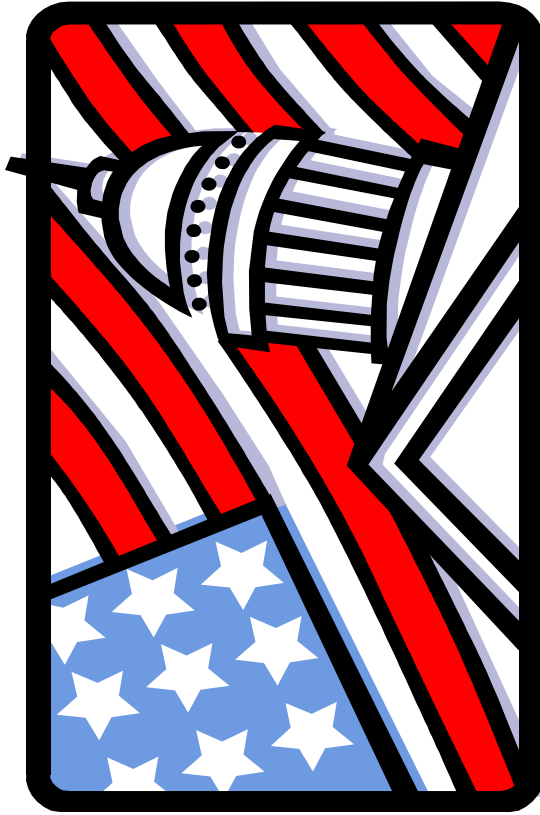
