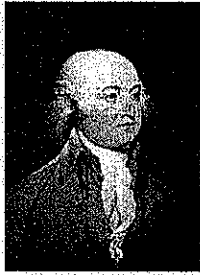

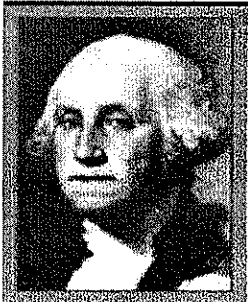
### NOTICE
