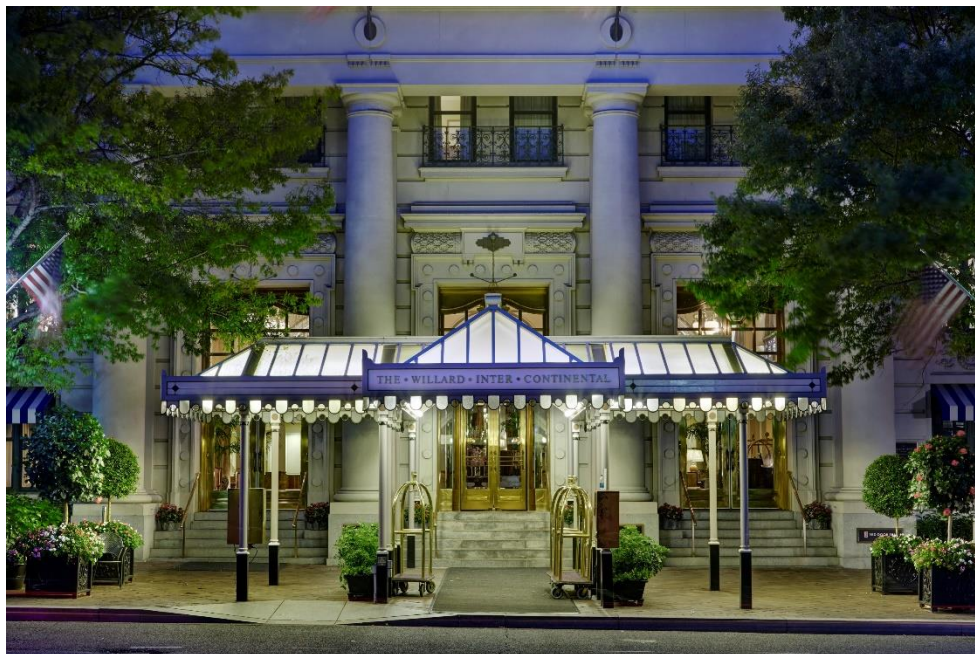

## About NAFUSA

**The National Association of Former United States Attorneys** was founded in March 1979. It was established to promote, defend and further the integrity and the preservation of the litigating authority and independence of the office of the United States Attorney as one of the principal instrumentalities through which the President of the United States carries out his/her constitutional obligation that the laws be faithfully executed. The association also provides a forum for education and continuing professional relationships that have been formed with the Department of Justice and for the exchange of information and professional referrals in the private practice of law.

An annual conference is held each year which features continuing legal education programs of interest in the areas of federal practice, Department of Justice policies and significant cases. Past conferences have featured former Chief Justice William H. Rehnquist, former United States Attorneys General Eric Holder and Janet Reno, FBI Director Christopher Wray, former FBI Director Robert Mueller and Deputy Attorney General Lisa Monaco.

Membership is open to persons who have served as a United States Attorney pursuant to a presidential commission. Also eligible for membership are former Department of Justice officials who have served pursuant to a presidential commission and persons who have served as a United States Attorney by court appointment or by designation from the Attorney General of the United States.
